## **Clubhouse & Pool Guidelines**

- Only North Brandon Shores Members (lot owners) may reserve the clubhouse, and that Member must be present during the entire function for which the clubhouse was reserved.
- The clubhouse may be reserved for a maximum of four hours per reservation during the hours of 9:00 A.M. to 12:00 A.M. All guests must be gone, cleaning completed, and doors locked by 12:00 A.M. (midnight). Also, a Member may not reserve the clubhouse for subsequent dates until the initial reservation date has passed. (Pool hours are 9 A.M. to 9 P.M.)
- Reservations for the clubhouse will be made on a first-come, first-served basis by completing a Clubhouse & Pool Reservation Form and by paying a \$25 rental fee and a \$100 damage deposit (two separate checks). The damage deposit will be returned provided all guidelines have been followed and the clubhouse has been properly cleaned.
- Individuals reserving the clubhouse may have access to the pool, along with all other Members, **during normal pool hours** for no additional fee.
- The pool may be reserved on **THURSDAYS ONLY** (excluding holidays) from 6-8 P.M. for \$25, with a \$100 deposit. The cost of reserving the pool and the clubhouse together is \$50, with a \$100 deposit.
- Cancellation of reservation must be made at least 48 hours prior to the scheduled event in order to receive a full refund. If not made by that time, the rental fee will be forfeited and only the damage deposit will be returned.
- No wet swimming suits are allowed in the clubhouse. Those using the clubhouse who choose to swim must access the bathrooms from the pool entrance outside.
- No smoking inside the clubhouse or area surrounding the pool.
- When reserving the clubhouse, outside noise should be kept to a minimum after 8 P.M.
- Any damage done to the clubhouse/pool, to the furnishings in the clubhouse/pool area, or to the clubhouse/pool grounds in excess of the \$100 damage deposit will be the responsibility of the Member who reserved the clubhouse.
- The pool will open the first Saturday in May and will close the last Sunday in September.
- Members should observe all posted rules and be considerate of other guests and nearby residents. Current pool rules are shown on the back of this page.

## POOL RULES

In order to comply with all state health laws and insurance requirements, everyone must strictly adhere to the following rules:

- 1. SWIM AT YOUR OWN RISK! NO LIFE GUARD ON DUTY!
- 2. Pool hours are 9 a.m. to 9 p.m.
- 3. Glass containers and alcohol are not allowed.
- 4. Children 15 and younger are not allowed in pool or pool area unless accompanied by an adult, parent, or guardian.
- 5. Pets are not allowed in pool or pool area at any time.
- 6. Whether sunbathing or swimming appropriate attire is required (i.e. decent, no cut offjeans, no boxer shorts, etc.).
- 7. Babies must wear appropriate protections (swim diapers).
- 8. Running, boisterous water games, fighting and loud activity will not be permitted at any time.
- 9. Do not put articles of foreign matter in pool. Do not leave trash in the pool area.
- 10. Members must accompany all guests
- 11. IF YOU SWIM ALONE, YOU DO SO AT YOUR OWN RISK!
